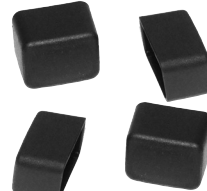

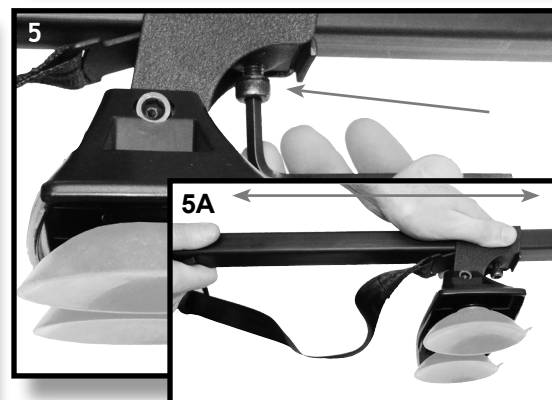
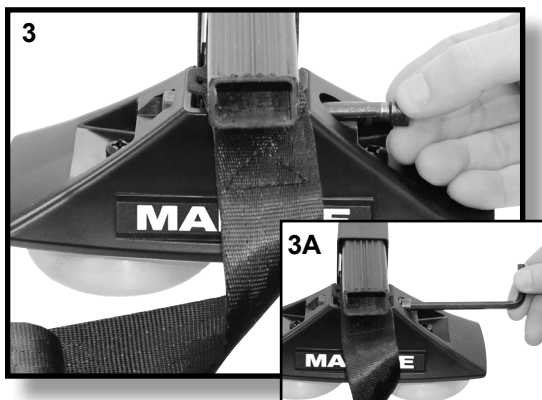

Assembly & Use Instructions - Please Read Before Beginning

FOR USE WITH BARE ROOFED VEHICLES

Assembling The Cross Bars

1. Insert the tower attachment bracket into the top of the tower as pictured in figure 1.
2. Capture the nylon lock nut in the hex shaped hole of the tower. See Figure 2
3. Insert Allen bolt into the remaining round hole and secure with provided wrench. Do not over tighten. See Figures 3 & 3A
4. Add the end caps to cross bars. Push firmly to secure. See Figure 4. Repeat steps 1 thru 4 to complete remaining 3 towers.
5. With assembly complete, loosen the towers set screw on the underside of the tower attachment bracket. This will allow the tower to slide along the cross bar so we can fit it to the vehicle's width. NOTE: We will tighten this screw after fitting the vehicle. See Figures 5 & 5A



You should now have two(2) completely assembled cross bars ready to install.



Review the previous steps if yours does not look like the photo.

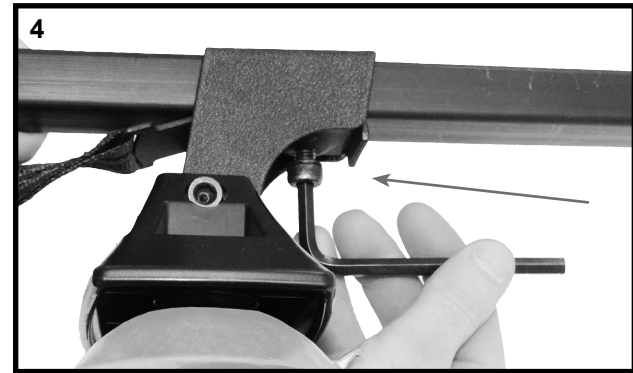
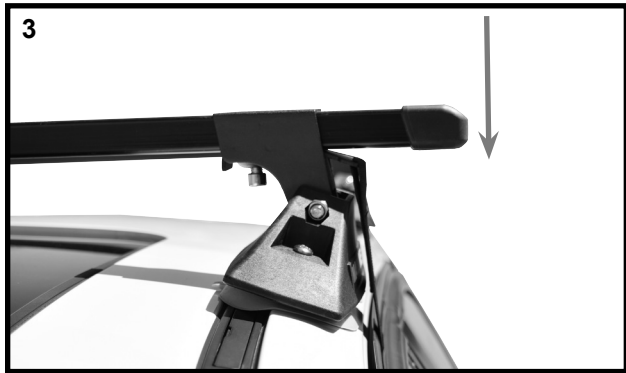
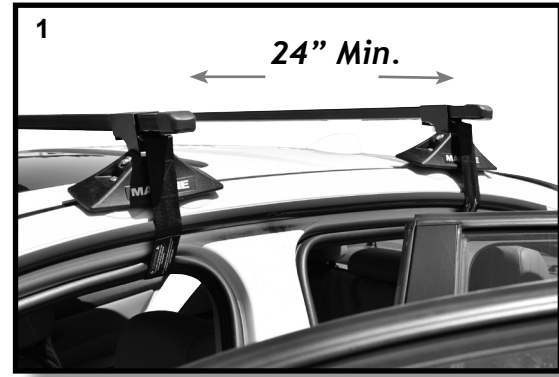
IMPORTANT NOTE ON MOUNTING:



- **CAREFUL ATTENTION MUST** be made to the placement of the towers on the vehicles roof. This is a very critical step to safety and function.
- The proper placement is right along the edge of the roof, at it's strongest point. The vacuum cups will act as cushions or pads even if placed over roof ridge lines preventing a full seal.
- Do Not place towers inwards or on a glass sunroof.

Mounting The Cross Bars: Continued

1. Begin with opening the vehicle's doors and place cross bars in desired location. Measuring at least 24" between them See Figure 1
2. Slide the tower(s) along the cross bar and place the tower(s) as to close to the edge as possible (see more sample images below). See Figure 2
3. With the towers placed as to close to the edge as possible, secure the towers by firmly pressing them downwards securing them to the roof. See Figure 3
4. With the cross bars in position, Go back and fully tightening the towers set screw that we loosened in step 5 of the assembly. See Figure 4

Mounting The Cross Bars: Continued



5. Pull the load strap through the vehicle, and into the large cam buckle from the rear. See Figure 5



6. Pull firmly towards you to tighten. Push/pull the secured strap downwards to check the security/tightness. IF the strap loosens, re-do the strap through the back of cam buckle. See Figure 6&7



7. Neatly fold up any leftover strapping and secure with the hook and loop enclosure.

Your VersaRail™ system is now complete!

Be sure to double check all hardware and straps prior to transport.

Limited Five (5) Year Warranty

The Malone Auto Racks (Malone) Limited 5 Year Warranty covers certain Malone-brand products that have been specifically identified for inclusion in the program. This warranty is in effect for five (5) years, from the time of sale, for the original retail purchaser of the product. This warranty is terminated after five years from the date of purchase, or, when the original retail purchaser sells or otherwise transfers the product to any other person or entity during the five year warranty period.

Subject to the limitations and exclusions described in this warranty, Malone will remedy defects in materials and/or workmanship by repairing or replacing, at its option, a defective product without charge for parts or labor. Malone may elect, at its option, not to repair or replace a defective product but rather issue to the original retail purchaser a refund equal to the purchase price paid for the product, or credit to be used toward the purchase of a replacement Malone product.

This warranty does not cover, and no warranty is given for defects or problems caused by normal wear and tear, which includes, but is not limited to, surface (aesthetic) metal corrosion, scratches, dents, deformities, accidents, unlawful vehicle operation, or any modification of a product not performed or authorized in writing by Malone.
